NIEI Personal Data Privacy Statement and Consent

for NIEI Courses

- Your personal data privacy is important to us and we are committed to safeguarding your personal data. Please read this privacy statement carefully so that you know and understand the purposes for which we collect, use and disclose your Personal Data. In this document, the term "Personal Data" means data, whether true or not, about you where you can be identified either (a) from that data; or (b) from that data and other information to which we have or are likely to have access.
- 2. In this document, "we", "our", "us" and "NIEI" refer to NIE International Pte Ltd and its successors and assigns. "NTU" refers to Nanyang Technological University and "NIE" refers to National Institute of Education, Singapore.
- 3. We may collect, use, disclose and process your Personal Data for one or more of the following purposes:
 - a) to facilitate, process, dealt with, administer, manage and/or maintain your application to participate in the course/ programme administered, conducted and/or organised by NIEI ("NIEI Course") and to facilitate, administer and manage your participation and involvement in the NIEI Course ("Relationship");
 - b) for programme administration and billing.
 - c) to create and maintain participant's profiles in our system database for internal records and reference;
 - d) to enable the trainers/ speakers/ guides to facilitate the conduct of the NIEI Course, including identifying and understanding the background of the participants;
 - e) to submit the data to NTU offices/ schools/ departments/ centres or external organisations who are hosting any visits (which are made available to participants) for their information and/or seek security clearance to enter their premises;
 - f) to arrange visa and accommodation for participants (if applicable);
 - g) to apply for student pass, student card, internet access, insurance coverage and access to NTU facilities (if applicable);
 - h) to issue letter of invitation, certificate to participants and other required documents (if applicable);
 - where applicable, to submit your details to NTU University Advancement Office (or the equivalent office in NTU and/or NIE) if the participants are accorded NTU Associate Alumni (or similar) status;



- j) to understand and study the profile of the participants for NIEI, NTU and NIE's policy making and planning;
- k) to generate publicity materials for our courses, events and programmes;
- I) to contact you by email, post, voice call, text (SMS/MMS) or fax;
- m) to send you information, materials and/or documents relating to activities, events, products and/or services that are intended for or are part of your programme/ course (including any information, materials and/or documents on related courses/ programmes/ events);
- n) to take or record photograph(s) or video image(s) for purpose of recording your participation in your programme/ course (including activities which form part of such programme/ course) and which may be used, disclosed, processed and published in materials such as newsletters or other publications or any materials/ books recording your participation in such activities; and
- o) any other purposes as we may seek (and obtain) your consent for from time to time (collectively, the "**Purposes**").
- 4. We may need to disclose your personal data to third parties, whether located within or outside Singapore, for one or more of the above Purposes, as such third parties, would be processing your Personal Data for one or more of the above Purposes.

It is our policy to retain certain personal data of participants upon the withdrawal of their Relationship (including termination or cessation of participation in the NIEI Course), so long as such personal data is still relevant for the purpose(s) for which it was collected and/or we have a legal or business purpose to keep the same. Without limiting the foregoing, such personal data may be required for any related activities including but not limited to processing your requests and allowing us to fulfil contractual or statutory obligations.
